I, _____, acknowledge that BHSI has the right to obtain information from law enforcement agencies, (e.g., local police departments, Criminal History Systems Board) regarding myself and all members of my household (18 years or older) relating to any and all drug-related or violent criminal activity. I further acknowledge that if BHSI determines that I or any family member (18 years or older) have participated in such drug-related or violent felonies, then I and my family may be denied eligibility, or may be terminated from a Rental Assistance Program. I authorize BHSI to obtain any criminal offender record information (CORI) from the Criminal Systems History Board (MA Department of Public Safety.) This information will be used to evaluate my household's application for housing assistance. If an adverse decision is based on this material, I will receive information on my right to dispute this report. I also understand all CORI information is destroyed after BHSI has determined me eligible. No material collected through the CORI verification process will go into my permanent tenant file.
